## 2022 MINI/PONY MEASUREMENTS

1. All mini's/ponies must have a valid permanent measurement certificate issued prior to December 31, 2021, or a valid annual measurement certificate (an annual measurement certificate is valid from date issued through December 31 of year issued), or be measured at the show. The measurement certificate shall be inspected by and have a copy on file with, the show secretary, prior to said animal showing in its first class of the show.
2. After the mini/pony is measured at a show, an annual measurement certificate can be issued by submitting \$5.00 with the completed measurement form to PtHA. **If the annual measurement certificate is not applied for, the mini/pony must be measured at each show by the certified PtHA representative(s) assigned to that show.**
3. All measurements must be done by the certified PtHA representative(s) assigned to the show with a certified measuring stick.
4. There will be a designated time and place for measurements to occur at the show. It is the owner's responsibility to contact the assigned PtHA representative(s) to schedule an appointment during the designated time period and bring the mini/pony to the designated measurement area. The time, area, and contact information for the PtHA representative(s) will be announced prior to the show.
5. The owner of the mini/pony is responsible for producing a copy of the PtHA registration certificate and filling out the PtHA measurement form before their scheduled appointment time and bringing those documents with them to the appointment. If wanting to apply for an annual measurement certificate, the owner shall have their method of payment ready at the appointment time.
