

HDPtHA & PtHA RULES

PtHA rules will be followed and enforced. KNOWLEDGE OF THESE RULES ARE THE RESPONSIBILITY OF THE EXHIBITOR AND OWNER(S). Please refer to the 2015 PtHA rule book regarding specific rules. All classes will be judged using guidelines set forth in the current years rule book. In absence of specific rules, show management has the final decision.

You must be a current member in good standing of the PINTO HORSE ASSOC of AMERICA to show in any Pinto classes to earn points.

Membership is required for all the exhibitors & horse owners to be eligible for yearend awards. You must show at both shows, and in 3 of the qualifying classes per division for the daily and yearend awards. Horses shown in open classes are not required to belong to any registry.

Registration papers and membership cards, proving current eligibility MUST BE PRESENTED, including Youth and Amateur cards.

WALK TROT/JOG riders cannot cross enter into any other performance class that would require a LOPE/CANTER. The Charity Walk Trot Class is open to ALL exhibitors but is not included in the all day fee.

Stallions are not to be handled or exhibited by a youth. Classes with 3 or less entries may be cancelled, combined or ran concurrently if permissible.

CLASS ADDS OR SCRATCHES & TACK CHANGES

All class changes are to be completed at least (3) classes in advance. IT IS THE RESPONSIBILITY OF THE EXHIBITOR, or their representative to properly notify the show office/gate person of any classes that have been added or scratched. Please advise also of any necessary tack changes at least (3) classes in advance. Gate adds are permitted.

SHOW DAY PINTO HORSE REGISTRATION

The hours may be divided between shows. The McCoy Equestrian Center also requires that horse exhibitors maintain the grounds by picking up after ones self. This includes trash and manure as well.
